A motion was duly made by Mike Betts and seconded that the RD Master Board formally invite each neighborhood Association's Board (Homes, Hammocks, Bel Mare, Laguna, Marina) to appoint one delegate each (any unit owner) who, along with one RD Master Board member as the chair, will form an "Exploratory Security Committee" of the RD Master Board, for the purpose of determining the feasibility of having the RD Master Association provide selected security services for all neighborhoods. Such Exploratory Security Committee shall commence only if all the neighborhoods appoint a delegate, and then will continue until it either becomes a permanent "Standing Security Committee" as a result of the RD Master Association assuming security responsibilities recommended by the committee, or it is disbanded because it has determined that such a security undertaking by the RD Master is not feasible in the foreseeable future. # Notes on Meeting regarding RD Security Mike Becks and JJ Kelly 1/27/15

Beginning of the discussion surrounded a variety of individual concerns of Bel Mare, Master Assn concerns in general, and Laguna. After considerable micro discussions, it was put forth that it MUST be a top down evaluation to engage all parties, i.e. communities within FID to determine if there are Security issues and if so, how would they best be handled.

We agreed there are global security issues as well as specific community concerns that are very different in scope. Over the past few years a bottom up approach has yielded little movement, as each community has their own agenda. As such, the Master is the only organization within RD that can blanket the discussion and determine the best way to move forward.

We are recommending that this topic be put on an upcoming agenda of the Master Assn. In order to get a sense of the interest/concern of all parties. Our goal would be to set in motion as ad hoc research committee authorized by the Master, represented by each community within RD to study the subject and prospective alternatives/solutions. Timing appears to be good as the budgets have been set for 2015 but we have time to properly evaluate over the rest of 2015.

Even though we identified certain security issues, many have specific nuances. Some may be mitigated by an overarching authority and some probably not. Specific issues we identified are:

- Cost and administration of an onsite presence
- Greater coverage utilizing newer technologies and off site Monitoring
- Harbor security that affects all RD owners and residents
- Multiple Entrances and how that impacts the entire community

- Need for at least a limited human interface within the community and challenges of that approach
- Varying needs of the multi-family units vs. detached homes
- The roll of the Master Assn. in the security role

These are but a few of the questions that we identified. We feel that the Master Board needs to put its creditability behind this concern and bring forth a comprehensive analysis for all to input and agree or not.

# **Motion for Ad Hoc Security Committee**

Motion: ...that the RD Master Board formally invite each neighborhood association's board (Homes, Hammocks, Bel Mare, Laguna, Marina?) to appoint one delegate each (any unit owner) who, along with one RD Master Board member as the chair, will form an "Exploratory Security Committee" of the RD Master Board, for the purpose of determining the feasibility of having the RD Master Assn provide selected security services for all neighborhoods. Such Exploratory Security Committee shall commence only if all the neighborhoods appoint a delegate, and then will continue until it either becomes a permanent "Standing Security Committee" as a result of the RD Master Assn assuming security responsibilities recommended by the committee, or it is disbanded because it has determined that such a security undertaking by the RD Master is not feasible in the foreseeable future.
