- V. New Business
  - A. Ingress/ Egress Easement Riviera Dunes Way- Karen Maller, association attorney explained the documents referencing the ownership of Riviera Dunes Way and its ownership which is The Riviera Dunes Master since the turnover by Developer and any changes to the roadway should have been be presented to the Master Board / MARC for any approvals per the documents.
