V. Committee Reports

- a. Finance: Firework damages at the Walkways- Discussion of outstanding reimbursement of expenses by Marina. Ed Talman has invoiced & will follow-up asap.
- b. Security: Replacement Security Camera Rob Hartwell presented proposal for 3 Cameras that are broken be replaced & upgraded at the same time. Funds will come from Reserve Account #3680. No motion was needed as this was a replacement item and considered maintenance. Also, Lynn Daniel/Island Resident has generously donated \$1000 towards this expense.
- c. Landscaping: Replacement Lighting around the walkway- Drew Denick presented 3 quotes on new Fiberglass Lighting. Funds will come out from Reserve Account #3610 & Expense Account 7160. Motion Deborah Sperry, seconded by Rob Hartwell.

VII. Finance Report

a. Deborah presented a new Financial Chart of Accounts Cross Walk representing 2016-2020 May YTD. This document combines two previous existing chart of accounts & budgets. Presently, RDMA has a \$538 positive variance 2020 May YTD.

VIII. New Business

a. Bel Mare Condominium sold 1.42 acres - Open Discussion The Community Redevelopment Agency (CRA) Land purchase related to Haben and 7th Ave Roundabout. Karen Maller/RDMA Attorney— presented issues that will need to be addressed with the CRA & City of Palmetto asap. Approval will be required by RDMA ACC as noted in the Sixth (6) Amendment to the Master Declaration, dated 12/20/2007. A meeting to be arranged asap.

Areas discussed - water channeling, storm water planning, Palmetto Trails right away, responsibility of re-platting and Master plans & documents from prior management group, C&S. It was also suggested that RDMA should have representation to serve on the Palmetto or Manatee Planning Commission and/or the CRA.

b. Voting delegates & Assessments -Discussion of a review underway with Karen Maller/RDMA attorney. The sale of the Bel Mare parcel opened a conversation as to

how the parcel purchased by the CRA would be assessed by the Master. In researching, there was no written policy on how parcels and lots were assessed and assigned delegate votes in accordance with the Master Declaration and its Amendments. Shay Hawkinberry and the Attorney will meet with Coby Gaulien, past President of the Master Association, to review the process used by him and the previous CAM, Julie Conway, when parcels and lots are purchased and sold to determine how buyers are notified of the existence of the Master Association and related assessments and responsibilities to the Master Declaration, as well as how they came up with the formulas used to determine allocations.
