FOURTH AMENDMENT TO MASTER DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR RIVIERA DUNES

THIS FOURTH AMENDMENT is made this **20** day of October, 2003, by W.C. RIVIERA PARTNERS, L.C., a Florida limited liability company ("Declarant").

WHEREAS, a Master Declaration of Covenants, Conditions, Restrictions and Easements for Riviera Dunes ("Master Declaration") was recorded in Official Records Book 1616, Page 4557, as amended by that certain First Amendment dated April 23, 2001, and recorded in Official Records Book 1677, Page 1378, and by that certain Second Amendment dated June 26, 2001, and recorded in Official Records Book 1688, Page 4355, and by that certain Third Amendment dated April 4, 2003, and recorded in Official Records Book 1818, Page 5706, all of the Public Records of Manatee County, Florida; and

WHEREAS, Declarant reserved the right to amend the Master Declaration pursuant to Section 16.07 of the Master Declaration; and

WHEREAS Declarant desires to amend the Master Declaration to restate Section 10.02 as to the composition of the Architectural Control Committee ("ACC"); and

WHEREAS capitalized terms in this Fourth Amendment have the same meaning as defined in the Master Declaration, unless otherwise noted.

NOW, THEREFORE, Declarant hereby amends the Master Declaration by deleting Section 10.02 and substituting in its place the following:

10.02. Architectural Control Committee. Architectural Review shall be implemented by the ACC. The ACC shall consist of five (5) members. The members shall be Michael A. Fernandez, Dennis D. Bradford and C. Timothy Vining, and two other members selected by Declarant prior to the Turnover Date and, thereafter, the two other members shall be appointed by the Board. In the event C. Timothy Vining ceases to serve as a member of the ACC, his replacement shall be selected by Riviera Dunes Development Partners, L.L.C. (or its successor that is assigned this right). The method of selecting a chairman and other similar provisions for the conduct of its proceedings shall be as provided from time to time by the members of the ACC. To the extent such matters are not

provided by this Master Declaration, the Board may promulgate rules from time to time, and to the extent the Board has not so promulgated rules, the ACC may promulgate such rules; provided, however, that all such rules must be consistent with this Master Declaration.
