- b. Approval of Minutes A motion was made to approve the May 24, 2021 minutes by Drew Denick, seconded by Rob Hartwell. 7-0 None opposed. *Motion passes*.

In the Open discussion Karen Maller, Association Attorney, explained why there is no need for a reason or cause for replacement and acknowledged Shay Hawkinberry has ownership & serves as an officer in GDAWG's LLC and that is why she can serve on the RDMA Board.
